Commissioner Ranstead motioned to accept board appointments, Commissioner Sommers seconded; carries 3-0.

AREA PLAN COMMISSION – Heather Redinger presented zone map amendments for consideration:

RESOLUTION OF THE FULTON COUNTY OMMISSIONERS TO ADOPT AMENDMENTS TO THE FULTON COUNTY ZONE ORDINANCE, SUB-DIVISION CONTROL ORDINANCE AND THE ZONE MAP

Resolution No: 01022024

A Resolution to Approve Amendments initiated by the Fulton County Plan Commission to the Fulton County Zone Ordinance, Fulton County Sub-division Control Ordinance and Zone Map. The proposed amendments were approved by the Fulton County Plan Commission at a legally advertised public hearing on September 25th, 2023.

WHEREAS, The Plan Commission of Fulton County, Indiana did on the 25th day of September, 2023 hold a regularly scheduled meeting of the Fulton County Plan Commission and considered amendments to the Fulton County Zone Ordinance, Fulton County Subdivision Control Ordinance and the Zone Map and did approve the amendments proposed by the Fulton County Plan Commission at a legally advertised public hearing on September 25th, 2023; and

WHEREAS, the amendments were initiated by the Fulton County Plan Commission; and

WHEREAS, said request did propose that said Fulton County Zone Ordinance, Fulton County Sub-division Control Ordinance and the Zone Map be amended as attached to Plan Commission Resolution PC-09252023

NOW, THEREFORE, BE IT RESOLVED, that the Fulton County Commissioners approve the amendments as celtified by the Fulton County Plan Commission to the Fulton County Zone Ordinance, Fulton County Sub-division Control Ordinance and the Zone Map.

The ordinance amendments will be reviewed again in the next meeting for the second and third reading.

HIGHWAY – John Geier updated on department activities. The first call for community crossings grant projects are open. There is \$1,500,000 in grant money available which will increase the grant match from \$333,333 to \$500,000. John presents a financial commitment letter for grant application submission. Commissioner Ranstead motioned to approve, Commissioner Sommers seconded; carries 3-0. Newly elected Rochester City Mayor Trent Odell presented an interlocal agreement between the City and County for Blacketor Drive. Commissioner Ranstead motioned to approve, Commissioner Sommers seconded; carries 3-0. John would like to purchase infrared heaters for the shop at a cost of \$2,000-\$3,000 each. He has funds available in the shop budget to make the purchase.

COMMUNICATIONS/EMA – Gail Karas requested the EMA and 911 meetings to be pushed back to the third week of the month to allow for advertising. The ADA meeting scheduled for next Tuesday will need to be rescheduled as well. The contract with Ritter Strategic Services for EMS Quality Assurance/Quality Improvement was discussed to run from January 2024 through December of 2027 not to exceed 160 hours per year at a cost of \$150 per hour. Commissioner Ranstead motioned to approve, Commissioner Sommers seconded; carries 3-0.

TIMES THEATER – Julia Shambarger gave an annual report for the Times Theater that has been open for 10 months. There were 8,963 people who visited and 99 events held. There are six volunteers on the operating committee.

PURDUE EXTENSION OFFICE – Jessica Riffle presented an annual update for Commissioner's consideration. She provided the Purdue Contract for approval. Commissioner Ranstead motioned to approve, Commissioner Sommers seconded; carries 3-0.

FEDCO – Michael Ladd stated that a representative from the state committee for the READI II grant will be visiting on January 11th to tour the site for the industrial park and Rochester High School for the childcare program. The region is allotted \$75 million but are requesting \$80 million. The additional \$5 million are being requested for other projects in the region. REMC contributed \$270,000 for the paving at Blacketor Drive.

ROCHESTER CITY MAYOR – Trent Odell announced that he plans to be aggressive in economic development and looks forward to collaborating with the county.
