FULTON COUNTY BOARD OF COMMISSIONERS MEETING

Friday, March 16, 2018

MEETING CALLED TO ORDER at 10:30 a.m. Present: Bryan Lewis, Rick Ranstead, Steve Metzger and Auditor Christina Sriver.

HIGHWAY – John Geier presented the bids for spring highway supplies:
