**Anyone age 5 and older may now schedule a COVID-19 vaccination
appointment.**

Booster doses are recommended for anyone 12 or older who received the second Pfizer doses at least **five** months ago, and anyone 18 and older who received the Moderna doses at least **five** months ago or who got the single dose Johnson & Johnson COVID-19 vaccine two or more months ago. Eligible individuals may choose which vaccine they receive as a booster dose. Some people may have a preference for the vaccine type that they originally received and others may prefer to get a different booster. CDC's recommendations now allow for this type of mix-and-match dosing for booster shots

STATE HEALTH DEPARTMENT ANNOUNCES CHANGES TO TESTING OPERATIONS

Due to high demand and a national shortage of rapid test kits

Rapid antigen tests are only available at some locations for anyone age 18 and younger and symptomatic individuals age 50 and older due to the limited supply. PCR tests with results in two or three days are available for everyone, regardless of age or symptoms.

Rapid- 18 years & younger OR Symptomatic 50 years & older

PCR- Anyone 2 years or older, Regardless of symptoms

Friday 8am-3:30pm

Saturday 9am-12:30pm
