RE: 3112 COUNTRY CLUB DRIVE- DRAINAGE PLAN

Bryan Lewis presented this drainage. Motion was made to approve this drainage plan. Motion passes 2-0.

RE: 2410 EAST STATE RD 14- DRAINAGE PLAN

Dan Dumoulin Sr is putting up a 60x40 foot building and he has 4.65 acres there is no need for water retention on this one due to there being enough acres for water. Motion was made to approve this drainage plan. Motion passes 3-0.

Michael Baker-North side of South Mud Lake putting up shed and he is going to have under ground storage for his water to contain it. He meets our requirements. Motion was made to approve this drainage plan. Motion passes 3-0.

Steve Rust- presented a drainage plan for Ramco Supply for Marvin. Marvin is building a new building and have new concrete around the building they want to take most all of the water and route it around the West side of the South building so there would be a catch basin subgrade system. Marvin wants to re-route his drainage to the West of the building to the retention pond. Motion was made to approve this drainage plan. Motion passed 3-0.

This ditch is one that Don Towne set up right before he left and we went back 4 years later. When you come into Miami county there is a fence on a landowner’s property next to the ditch on our 75 foot right of way. There is no way we can get a machine through it. A machine can go threw a little big where it jogs but the fence is right next to the ditch. Lacey sent letter out to landowner stating he will have to pull the fence back so our contractors can get machinery in to do their job. Dale pulled off said the water level wasn’t bad on that stretch. There is a Nipsco line that is big that goes through the ditch. It is right at the water level 18-foot dam that it is making and they refuse to do anything about it.

RE: CHARLES HARTER TILE

This is NOT ON MAINTENANCE, but Seth pulled the old plans and drew it in on the GIS. The plans do state that it runs to the road. If someone petitions to put this on maintenance then we would go off of the plans and the lines that Seth drew onto the GIS from the minutes. Until someone petitions to put this on maintenance we have no control over this tile.
