FULTON COUNTY BOARD OF COMMISSIONERS Tuesday, February 19, 2024

Meeting Called to Order at 6:00 p.m with Pledge to the Flag. Present: Bryan Lewis, Rick Ranstead, David Sommers, County Attorney Holli Shorter-Pifer and Auditor Representative Chantal Rensberger.

ABATEMENT – Lauren Adley presents for Ramco Tax abatement with Mr. Marvin Ramer. Ramco building supplies and Ramer properties. Due to expansions through out county and other counties, wants a larger building for expansions. Lauren expresses on the business side, petitioned for a tax abatement, asking for blessing for the tax abatement. Asking the recommendation of 10 years. Motion to approved carries 3-0 with Rick motioning and Dave seconding. They will present at Council meeting 2/20/2024.

FULTON COUNTY ANIMAL CENTER – Janet Showley from Fulton County Animal Center shares 2023-year end county report. States it was the best year for cat adoptions and save rates were steady for cats and dogs down 1%. At vaccine clinic saw 917 animals and profited \$30,000. Hired 3 part time veterinarians due to vaccine clinic going very well. The received a \$12,000 grant from Petsmart Charities in which the money will hire a part-time staff member. Pet food pantry is a huge need for the community as well as the volunteer program is likely the largest in Fulton County.

FULTON COUNTY H.O.P.E. – Amy Roe presents on the behalf of Fulton County H.O.P.E. Looking at hosting mental health chats to be at the Library. 4C Health will be doing the chats. Substance Use Symposium bringing the community together to make sure that needs are being met in regards to substance abuse. Brick and Mortar Wrap around Services. This project looks like making sure people understand resources and provide information to those in poverty. Self Sufficiency Program happening in Kosciusko County, HOPE will find out more information about this. Domestic Violence, March 15th, Beamon Home is having strategic planning session in order to meet the needs of the community. Communication methods, looking at ways to update communication and finalizing website. A survey will go around in regards to transportation with coordination from IUK Students who helped put the survey together in regards to transportation needs in Fulton County. Finally, pairing with Gail Karas in regards to warming stations for the homeless in Fulton County.

HIGHWAY – John Geier asks for permit request to install a driveway for Garrick Lease, 250 ft with 8 in Culvert. Motion carries 3-0. Rick motions, Dave 2nds. Nipsco asking permit for a driveway 24-7. Rick motions, Dave 2nds, Motion carries 3-0. Started working on Old 31 South, 11 new culverts before paving begins. They will be changing a lot of signs and cutting a lot of brush. On February 29th, ADA and Title 6, will have training with Christina Haughs and Department heads. Department heads will go back and train staff. LPA consulting contract discussed, Bridge #161 for construction inspection. Not to exceed \$205,000.00 with USI. Motion approved 3-0. Dave motions, Rick seconds. Zartman's here due to highway cutting out 3 trees that were not approved to cut on Nyona Lake Road, but actually owned by the county. Property purchased in 1938 by the State, 1976 State gave to County. Mr. Zartman speaks about where the trees split the road, over the years wife and him have tried to preserve this area. Ruts were left in the area, requesting a couple loads of dirt and have the stumps removed completely and furnish some trees and they will take care of the rest. He does not feel the trees that were cut needed to be cut. He is hoping that the county is open to helping preserve that area. Dave states we can get the trees and John says he will try and get good black dirt. John asking for blessing for travel request to the Road School.

Steven Fishburn talks about flags that had a budget of \$2,500 and give the check to the Legion and will divvy them up between the three clubs. Whatever is left will go into the honor guard fund. Said he spoke with Christina Sriver and he needs to do this a different way, a potential funding agreement. He would like to do this as soon as possible.
