# FULTON COUNTY COUNCIL Tuesday, February 20, 2024

Meeting Called to Order at 5:00 p.m. with Pledge to the Flag. Present: Phyl Olinger, Steve Fishburn, Lorie Hurst, Randy Gundrum, Chayse Thompson, Pete Karas. and Auditor Representative Chantal Rensberger. Not present: Ron Dittman.

RAMCO ABATMENT – Lauren Adley speaks on abatement for Marvin Ramer, Ramer Properties and Ramco. Asking for Tax Abatement due to expansion and hiring of 5-7 new employees. Wages averaging \$45,000/year, \$1.9 million expansion, \$1.2 million equipment. Real Estate and Personal Property, 10-year abatement for each. This is located in an economic development district. Lorie responded about never giving a 10-year abatement, possible sliding scale. Council will need to discuss if they be open to 7 years to personal property abatement but fears it may hurt in the long run. Typically, in the past we have given 5-year abatements for personal property. Steve Fishburn would like to help out as much as possible. Randy Gundrum states that in order to give an abatement, must give a good wage. Chayse Thompson would like to see a ten year for the personal property due to good employees. Lauren states 15-17 employees added per year. Randy Gundrum appreciates the fact he has employees and it keeps him grounded. Steve motions for 10-year tax abatement, Randy 2<sup>nd</sup>, motion 3-3. Nay Phil Olinger, Pete Karas, and Lorie Hurst. Yay Randy Gundrum, Steve Fishburn, and Chayse Thompson. Marvin Ramer speak and is thankful for whatever Fulton County to give to help. Phil Olinger changes vote to yes, 4-3 for Personal Property.10-year abatement on Real Estate, Steve Motions, Randy 2<sup>nd</sup>, Motion carries 6-0.

**PARK BOARD** – Bill Walsh delivered the department report to Council. A spreadsheet for fund 1179 and Grants and donations received throughout the years has been created. Spoke briefly on Prairie's Edge and Bark Park. Mark states that eventually they are going to have to get employees and will have to ask for county funding as they will not be there forever.

**FULTON COUNTY H.O.P.E.** – Amy Roe speaks about the updates of Fulton County H.O.P.E and the needs of Fulton County. They are providing awareness through Facebook, online, brochures with phone numbers, mass mailings, and at the Library with chats for provider awareness. Presently they are working on a 2-year plan for what HOPE is wanting to achieve throughout the community.

SHERIFF – Derek Halterman stated there are 90 inmates in jail, 30 holding for Wabash County, 14 Federal inmates and 14 DOC inmates. Invoiced \$67,000 in inmate housing. \$551,0000 in inmate housing fund. Deputy Jay Salientes has started week 8 at the academy. Deputy Rick Utter will be the new SRO for Rochester Community Schools. Deputy Scott will train Utter. AED have been deployed with the deputies. Two Tahoes were ordered for 2024 and will replace the Durangos that are used for K-9s. Insurance is settling for the Ford Taurus that was struck on 31, \$9,500.00 settlement with \$500 deductible that our insurance is going after the other person's insurance to pay for. They are also going to try and get equipment paid for.

**EMA/COMMUNICATIONS-** Gail Karas states 20 radios up and running for Sheriff Department. The fire department are being programmed but not in our possession. Gail has all assets out at EMA and they will get shut off if not being used. Moving forward, county will be using the 800 system. EMA- Dawn Sewell here and introduced. This is National EMA Week, IDHS did interview Fulton County and it is

being shared all over nationally and on Facebook page. There are 20 volunteers along with Gail. Nominated as growing and exceling with communication in Indiana. Phyl asks about more work to do and upgrading, Gail states there is more work to do and moving EMS, Law Enforcement are on 800 along with Fire Departments on board with 800 pager systems and getting them programmed. Contract discussed, but not have the bill yet for it. Radios coming out of 911 funds, no need for appropriations. They are needing to update bathroom to ADA compliance. Need to replace doors and windows and starting to replace doors first. The Ford they obtained from Sheriff department needs to go to the shop. There should be no other big expenditures.

HIGHWAY – John Geier states brush cutter has been down Olson Rd and has been running quite a bit. Trees are being cut with REMC. Old 31 South changing culverts and county tiles with a federal aid grant and will repave the road (Phend and Brown). There is a lot of work going on and taking advantage of nice weather. Updating ADA and Title VI plans and will offer training on the 2/29/2024 with Department Heads and they will go back and train employees. March will present to commissioners and April will be adopted. It is mandatory for Federal Funding.
