FULTON COUNTY COUNCIL Tuesday, May 21, 2024

Meeting Called to Order at 5:00 p.m. with Pledge to the Flag. Present: Ron Dittman, Phyl Olinger, Steve Fishburn, Lorie Hurst, Randy Gundrum, Chayse Thompson, Pete Karas, and Auditor Representative Casey Jones.

HIGHWAY – John Geier- Updates council on activities, started chip sealing last week, almost completed Liberty township. Updated council on detours. SR 25 will be closed sometime around June or July. Informed council on intent to purchase a flail mower which he included is his budget for this year, so won't need any funding. Started mowing first of May, has three mowers going every day. Requests more than two weeks to train replacement for new hire, similar to the auditor's office request. Phyl motions to approve, Steve seconds; Motions carries 7-0.

EMS LIT Increase-Ron Dittman reads local ordinance #04162024b increasing the Emergency Medical Services tax from 0% to 0.2%. This ordinance will come into effect Oct 1st 2024. Pete Karas says it's a "necessary evil", as we need to have an ambulance service for our community and unfortunately a tax increase is the only way to pay for it. Phyl states that increasing local income tax rather than property taxes shares the load among the largest portion of our community, and the whole community would equally benefit from the ambulance service. Steve asks that if we receive future funding from state or federal sources to help pay for the ambulance service, can we rescind this LIT increase? Ron explained the costs to the county. Motion to approve by Phyl, Lorrie seconds; Motion carries 7-0.

Salary Amendment-Read by Ron Dittman, what changed was the Communications full-time dispatchers went from 8 to 9. Phyl motioned to approve, Steve seconds, motion carries 6-0, Pete abstains.

FEDCO Agreement-Read by Ron Dittman, only an accounting feature changed. Pete motioned to approve, Randy seconds, motion carries 7-0.

Auditors Request- Read by Ron Dittman, Auditor requests to start part-time employee earlier than the allotted two weeks, no new funds needed to support this. Steve motioned to approve, Lori seconds, motion carries 7-0.

COMMUNICATIONS – Gail Karas-The Emergency Management Performance Grant, in the amount of \$18,000, is deposited in County General.

SHERIFF - Travis Heishman

Jail and detention center population ordinance read by Ron Dittman, it is being reread due to commissioners changing some wording. Phyl asks Travis to clarify the changing in words to include "food, medical supplies and staff" in paragraph three to further clarify what the funds may be spent on. Steve Motions to approve, Randy seconds, motion carries 7-0.

Travis states he has previously mailed out April reports and asked if council if they had questions. Gave inmate updates, 130 inmates is roughly 55% capacity for the county jail. Made roughly \$47,000 last month and Travis projects double that next month. Phyl asked if that means we will be housing double the amount of out of county inmates and Travis replied that it does not this is just the first month of housing

that many out of county inmates. Last few weeks they celebrated law enforcement week, Travis thanked everyone for showing their support. Raised roughly \$1600 with "Ride the Lightening" fundraiser. Travis asking for Chad (Jail Maint.) asking for moving forward with purchasing a maintenance building using the maintenance fund. Pete says the council just needs to word the approval to state that as long as it is "self-funded" through the jail maintenance fund. Steve motions to approve Jail Maintenance building. Steve motions to approve, Randy seconds: motion carries 7-0.

MINUTES – Pete motioned to approve minutes of the April 16th meeting, Phyl seconded; carries 7-0.
