Meeting Called to Order at 10:05 a.m. with Pledge to the Flag. Present: Ron Dittman, Phyl Olinger, Steve Fishburn, Lorie Hurst, Randy Gundrum, Pete Karas and Auditor Christina Sriver. Chayse Thompson is absent.

Christina Sriver-distributes Form 4Bs, max levy worksheet, and current copy of 2025 budget projections to council members. She informs County Council that the 2025 projected budget for the County General fund (1001) needs to be cut by \$2.5 million dollars. Council discusses different ways of cutting the budget.
