Meeting Called to Order at 9:00 a.m. with Pledge to the Flag. Present: Bryan Lewis, Rick Ranstead, David Sommers, County Attorney Holli Shorter-Pifer. and Auditor Representative Chantal Rensberger

United Way- Lauren Adley presents, ARP fund to run campaign, would like to purchase a laptop. Discussion of campaign allocations, estimate of what laptop costs. Building is for sale, want to supplement our campaign \$17,600 for 2024, still want to purchase lap top and small equipment...want to sell building. Need a slight modification to the ARP application and forgive the funds and can allocate campaign funds better to our community. Selling for \$32,500 with Helt Realty. Office will be rent out of RTC on 8th Street. Motion to approve request- Dave Sommers Motions, Rick Ranstead Seconds. All in favor 3-0.

Request- for cell phone, laptop request, and mobile clock-in request for Brittany Thompson, Motions carries 3-0.

HIGHWAY – John Geier, permit request for Comcast to install cable, applying for same permit as current one is going to expire 9/4/2024. Extending permit for a year. Permit 2235- Rick motions, Dave seconds, carries 3-0. Change order for one of the federal projects for signs out on OLD 31 South. Rick motions, Dave seconds, motion carries 3-0. Highway is currently on 1000 E brush cutting, now moving to New Castle Township. Old 31 South on 9/5/2024 at 11:00, final inspection. Meeting at 31 and Old 31. Community Crossing 900 W-110 Paving done. 600 North beginning today. ST RD 14, still closed, INDOT shut down E&B pavement design. Liberty Mutual is paying for the oil spill, reimbursing HWY as well as future bills. HWY shop instillation people there to spay foam, and Twin Peaks coming out to measure out building for salt roof. Winter hours begin 9/4/2024, 7-3:30 pm, 5 days a week.

FEDCO- Michael Ladd discusses industrial park meetings with INDOT. They (Jim) want a new road on property line on North Side, not going to happen. He is reluctant to put the road in. Unsure why, issue with coming out of South 100 coming over hill and views. Discussing what will happen. Still working n Lily Endowment money. Regional group missed JULY deadline, have until September. Housing study with community business leaders, to discuss business needs in community. What kind of housing do we need to bring in different types of people. 5 developers looking to bill then there is FEDCO, this meeting was about "our project" needs. FEDCO and Club 720, trying to fulfill the needs of the housing study. This is a multi-year project. Hotel study still working on, did a survey states we need hotel, 50-65 rooms.
